The 108th Annual Session of the Texas State Association of Free Will Baptists will be meeting June 8-9, 2021, at First FWB Church in Duncanville. Board meetings will begin on Wednesday morning June 8, and the formal opening of the Annual Session will begin with the Wednesday evening worship service. Our keynote and conference speaker will be Daniel Webster, Director of Enrollment Services and Adjunct Instructor at Welch College.

Lodging for this year's State Meeting has been arranged at La Quinta Inn & Suites Dallas - Duncanville. The hotel has a number of rooms temporarily blocked at a reduced rate; to make reservations, please see the information below.

Rates include all standard amenities, such as free breakfast, parking, and high-speed Wi-Fi.

Ask for the Texas Free Will Baptist group. The default for our group rate is arrival on Tuesday (June 7) and departure on Friday (June 10). If your arrival/departure dates are different, you can specify that when you call the hotel. The reservation deadline to obtain the reduced group rate is no later than **May 17**.

As in years past, pre-registration is available and encouraged for all attendees. You may register using one of the registration forms sent to your church, mailing it to the State Office, or you may register online at www.texasfwb.org. We ask that you submit your pre-registration by May 31 in order to have your information compiled prior to the meeting. Onsite registration will also be available, but you are encouraged to pre-register if you know that you will attend. Pre-registration helps us to keep records more efficiently, and pre-registered attendees will have a pre-made nametag at the registration table.
